PET RELEASE AGREEMENT



Please adhere to the following rules and regulations.

When attending the Happy Paws Pet Expo I agree to the following rules & regulations stated below:

- 1.) To indemnify and hold harmless, the Happy Paws Pet Expo, Inc. for any and all claims of liability and damages from any injury, property damage, loss, claim, or expense that may occur to me while attending the Happy Paws Pet Expo.
- 2.) In attending the Happy Paws Pet Expo with my animal(s) and should any injury occur to any person, other animal or property as a result of the behavior of my animal(s) at the Pet Expo, whether expected or unexpected, regardless of the stimulus for the behavior (i.e., animal's spontaneous conduct, the conduct of another animal, the conduct of any person or thing, or a combination of any of these), I will be solely liable and be held responsible for any injury or property damage that results there from (including reasonable attorneys fees) and that I will indemnify, hold harmless, protect and defend the Happy Paws Pet Expo, Inc. or any other person, company or organization from any liability resulting from my pet's attendance the Happy Paws Pet Expo, Inc. event for any and all claims of liability and damages from any injury, property, damage, loss, claim, or expense resulting from the behavior of my animal.
- 3.) Attendee is to report any and all such injuries immediately to the Happy Paws Pet Expo, Inc. management.
- 4.) Attendees and participants bringing my pet into the Happy Paws Pet Expo, Inc. I understand that I am doing so at my sole risk, cost and expense and any harm that comes to the animal shall be solely my responsibility; and that I will be solely responsible; and that I will be solely responsible for cleaning up any messes made by my pet.
- 5.) I also state that my pet is healthy, free from parasites & has all the necessary shots including rabies, distemper for dogs & FVRCP for cats.
- 6.) Further, I understand that my pet acts in anyway considered aggressive or dangerous to other pets or people that I will have to leave the Happy Paws Pet Expo immediately and I will not be entitled to any refund. I understand that this release agreement is a contract and state that I have read all of its terms, am a legal adult (age 18 or older), fully understand them and am legally competent to execute this Release Form.
